AN ORDINANCE DECLARING CERTAIN PERSONAL
PROPERTY SURPLUS AND APPROVING AN
INTERGOVERNMENTAL AGREEMENT REGARDING
DISPOSITION OF SUCH PROPERTY

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF FOREST VIEW, COOK COUNTY, ILLINOIS, IN THE EXERCISE OF
THE VILLAGE'S HOME RULE POWERS, as follows:

SECTION 1: Declaration of Surplus: The following items of personal property are
hereby declared to be surplus:

- A. 2017 Ford Explorer Interceptor equipped as a police K-9 vehicle, VIN Number
1FM5K8AR1HGE13183; and
- B. Police K-9 named Ali, a male German Shepard, Chip No. 9000079000337477, and
associated K9 equipment.

SECTION 2: Intergovernmental Agreement Approved. The President and Board of
Trustees of the Village of Forest View hereby approve of an Intergovernmental Agreement with
the Village of Stickney, substantially in the form attached to this ordinance, under which the
property declared surplus in Section 1 of this Ordinance is to be exchanged for property owned by
the Village of Stickney, which property is described in the Agreement.

SECTION 3: Home Rule. This Ordinance and each of its terms shall be the effective
legislative act of a home rule municipality without regard to whether such ordinance should (a)
contain terms contrary to the provisions of current or subsequent non-preemptive state law, or (b)

legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the Village of Forest View that to the extent that the terms of this Ordinance should be inconsistent with any non-preemptive state law, that this Ordinance shall supersede state law in that regard within its jurisdiction.

SECTION 4: Full Force and Effect. This Ordinance shall be in full force and effect from and after its passage and approval and shall subsequently be published in pamphlet form as provided by law.
