## Specialty Units – K-9 and Investigations

Officer Rivera is the K-9 handler for the Forest View Police Department. Rivera and K9 Ali were placed in service on August 5<sup>th</sup> 2018, after K9 Officer Rivera attended six weeks of intensive K-9 Handler training. On August 5<sup>th</sup>, 2018 K9 Officer Rivera and K9 Ali were placed in service. As an industry standard for K9 training, in 2019 K9 Officer Rivera and K9 Ali attend two (2) 8-hour training days per month with Full Circle K9 Solutions for maintenance training. During their training sessions they receive scenario base training, as well as training in narcotics vehicle and room searches, tracking, article/evidence search and recovery, and obedience. In 2019 K-9 Officer Rivera and K-9 Ali also attended the following specialized training listed below, as well as the State of Illinois mandated narcotics certification and Nationally certified with (NAPWDA) North American Police Work Dog Association and was utilized for the K-9 callouts also listed below.

### Training

- Attended a K-9 First Aid Trauma class hosted by Dr. Newman of Partners and Paws.
- Attended a four day Enhanced Narcotics Detection training class hosted by the US Government run Midwest Counter Drug Training Center free of charge.
- Attended a Drug Interdiction Class hosted by the US Government run NorthEast Counter Drug Training Center Free of charge.
- Attended the North American Police Work Dog Association national conference where during the course of four days had the opportunity to train with K9 teams for around the United States and supervised by nationally certified trainers also from around the United States.
- Attended and Passed the Illinois Narcotic certification course.
- Attended and passed the national North American Police Work Dog Association course.

The following were the deployments that K9 Officer Rivera and K9 Ali were involved in for 2019.

- Requested by MCAT to assist Lyons PD on a search warrant in reference to a shooting.
- Requested by Cicero PD to assist with the track for a autistic female that was missing.
- Responded for the Activated Burglar Alarm and conducted a search of the business.
- Requested by Riverside PD to assist with the search for a subject that fled of foot from a officer.
- Requested by Stickney PD to assist with the K-9 Sniff of \$13,000 USC for presence of narcotics.
- Requested by Stickney PD to assist with the K-9 sniff of a vehicle in their station for the odor/presence of narcotics.
- Requested by Cicero PD to assist with the school locker search for narcotics.
- Requested by North Riverside PD to assist with the vehicle sniff on a traffic stop.
- Assisted Stickney PD with the search for the male that climb through a residential window.
- Requested by MCAT to assist Lagrange Park PD with the attempt to apprehend subjects stealing ATM's from businesses.
- Requested by Stickney PD to assist with the vehicle sniff of a vehicle in their station for the odor/presence of narcotics, to obtain a search warrant.
