**RESOLUTION NO. R24-07**

**A RESOLUTION AUTHORIZING THE TRANSFER OF CERTAIN MONIES TO  
THE FOREST VIEW POLICE PENSION FUND FOR FISCAL YEAR 2024**

---

**WHEREAS**, the Village of Forest View is a home-rule unit of local government pursuant to the provisions of Article VII, Section 6 of the Illinois Constitution of 1970; and

**WHEREAS**, as a home rule-unit of local government, the Village may exercise any power and perform any function pertaining to its government except as limited by Article VII, Section 6; and

**WHEREAS**, the President and Board of Trustees of the Village of Forest View, Cook County, Illinois have discussed the financial position of the Police Pension Fund and recently received the results of the financial operations for Fiscal Year 2022-2023 that ended on April 30, 2023 and have determined it is in the best interest of the Village to transfer certain sums of money from the General Corporate Fund to the Forest View Police Pension Fund.

**NOW, THEREFORE BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FOREST VIEW, COOK COUNTY, ILLINOIS as follows:**

**SECTION 1.** That the Village Accountant is hereby authorized and directed to transfer the sum of \$200,000 (Two Hundred Thousand and 00/100 Dollars) from the General Corporate Fund to the Forest View Police Pension Fund; and

**SECTION 2:** This transfer will be effective immediately upon its passage by the Village President and Board of Trustees and shall reflect in the Village of Forest View audit and financial statements as of April 30, 2024; and

**SECTION 3:** This resolution shall be in full force and effect from and after its passage; and

**SECTION 4:** This resolution and each of its terms shall be effective legislative act of a home-rule municipality without regard to whether such resolutions should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the Village of Forest View that to the extent that the terms of this resolution should be inconsistent with any non-preemptive state law, that this resolution shall supersede state law in that regarding within its jurisdiction.
