## AN ORDINANCE AMENDING SECTION 3-3-22 OF THE FOREST VIEW VILLAGE CODE, "VIDEO GAMING," TO INCREASE THE VIDEO GAMING TERMINAL PERMIT STICKER FEE

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FOREST VIEW, COOK COUNTY, ILLINOIS, IN THE EXERCISE OF THE VILLAGE'S HOME RULE POWERS, as follows:

**SECTION 1: Amendment:** Section 3-3-22 of the Forest View Village Code, "Video Gaming," is hereby amended by amending Section (E), "Video Gaming Terminal Permit Sticker," to provide as follows [New language **bold** faced]:

(E) Video Gaming Terminal Permit Sticker: In order for a video gaming terminal to be operated at a licensed establishment, the licensed establishment is required to obtain an annual video gaming terminal permit sticker from the village for each video gaming terminal located on its premises by submitting a written application, on a form provided by the village clerk. Each video gaming permit sticker issued by the village shall expire December 31, next, after the date of issue, with an annual fee of twenty five dollars (\$25.00) five hundred dollars (\$500.00) per video gaming terminal payable in full at the time the annual application is filed with the village.

This annual fee shall be shared equally between the terminal operator and the applicable licensed establishment.

SECTION 2: Home Rule. This Ordinance and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such ordinance should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the Village of Forest View that to the extent that the terms of this

Ordinance should be inconsistent with any non-preemptive state law, that this Ordinance shall supersede state law in that regard within its jurisdiction.

**SECTION 3: Effective Date.** The fee imposed by this ordinance shall take effect January 1, 2023. This Ordinance shall be in full force and effect immediately upon its passage and approval and shall subsequently be published in pamphlet form as provided by law.
