11. REPORTS FROM VILLAGE ADMINISTRATOR:

Village Administrator Mike Dropka provided the following details:

- Communicated that a long-time business owner of the Tool Store has sold his business and is in the process of changing ownership.
- Reported that the work with Azavar is near completion after we found several issues. He stated that the village has two gas stations who pay Home Rule Motor Fuel Tax and have been using outdated forms. Azavar is working on coming up with a better reporting system that will soon allow them to pay their tax online and we will be able to better track what they are reporting to the state and will be able to ensure that the tax received is what we should be receiving. He commented that while working on this project he has found that there are other companies in Forest View who supply gas to their employees or workers or trucks as they have gas tanks on site but don't resale the gas. He stated that our ordinance does not exempt these businesses from paying the home rule sales tax even though they are not selling gas, they have never paid tax. We are working on educating these businesses that they start filing and paying tax on the gas they use to the village. He is estimating that

this will be a substantial increase in revenue for the village. Once they start filing the tax, we will be able to go back and negotiate with them how much they owe from the years that they have not been filing. He stated that he will bring an ordinance to the next board meeting to consider, which will create a business license for fuel distributors that will include a nominal license fee that will only be used for tracking purposes. He stated that we currently do this with the garbage license fee, so when they pick up garbage on private businesses they register with the village and pay this fee to pick up the dumpsters.

- The Red-light camera project continues to be ongoing.
- He continues to meet with Muniweb on a website for our documents.
- Discussed that he will begin meeting with department heads to put together a Budget for this next fiscal year and will need to file our appropriations ordinance by July 31, 2023.
- Announced that the board will be conducting interviews for the Chief of Police position tomorrow and Thursday.

11. REPORTS OF OFFICERS:

A) DEPARTMENT HEADS:

Superintendent of Water and Public Works Filec reported:

- Reported that public works is redoing and grinding the fire hydrants and will be painting them next week.
- Public Works will be putting up flags for Memorial Day tomorrow.
- Reported that they will be replacing a fire hydrant that was struck by a car on Harlem Avenue once they get the new hydrants in stock.
- Working with Novotny on the Salt Dome and will be using the grant received.
- Working with National Power Rodding regarding the tunnel project.

Police Chief Stelter:

- Thanked everyone for coming out.
- Announced that the Forest View Police department participated in the Cop on Top for Special Olympics and raised over \$3,000. He thanked the residents who stopped, donated, purchased t-shirts, and coffee and donuts. He wanted to give a shout out to Sgt Perez and Zarate and Officers Mullica, Carrillo, Sanchez, Kulaga and Collins who donated their time for this event.
- He thanked the village for the last 15 months and letting him get to know the community.
